 - 4.1.1 Ordering of materials was smoother this year

- 5. Adoption of the Minutes from June 2016 Sherry adopted, Natasha seconded
- 6. Reports
 - 4.2 President's Report Sherry
 - 4.2.1 Hope to sneak another fundraiser in this year; explained to new members that we used to have just the annual High Tea, the amount it raised, why the funds are so important, lack of volunteers last year
 - 4.3 Vice President's Report Natasha
 - 4.2.2 RibFest went well with a good turnout of volunteers given this was a last minute initiative
 - 4.2.3 Wants to start brainstorming ideas next month so we have more planning time to hopefully launch in January 2017
 - 4.4 Treasurer's Report Michelle
 - 4.2.4 spoke to new members to give CVMS background, including start up was parent driven with parent fees/donations/fundraising requirements to fund everything; SD71 is in it's 2nd year of funding \$20,000 to Montessori but is still the responsibility of CVMS to fund new classrooms at a cost of approximately \$15,000/room; broke down the role of Treasurer; explained when the fiscal year is, approximate annual costs to run the Society & what that entails
 - 4.2.5 RibFest WestJet Tickets Thank you to Roseanne for the bulk of the organization; great volunteers; due to error of Rotary in allowing the Cadets on site also selling raffle tickets, they agreed to take a smaller portion of the shared profits, at 40%, equally approximately \$3000 to Rotary & \$4515 to CVMS; we sold 784 tickets (of 1500 available) in 21 hours; expenses were \$150 to print the tickets then the cost of the brochures which are allotted to overall expenses, since we use them at open houses, etc.

- 4.2.6 Insurance cheapest policy costs \$1000. Insurance is necessary re: liability & Montessori materials. Discussed whether we wanted additional insurance to protect liability of Directors Sherry reminded we need final ok from the school Principal for everything we do, therefore everything would fall under the school's liability, not ours; Natasha will investigate to ensure this is accurate.

- 4.6 WestJet Fundraiser Report Roseanne
 - 4.2.9 Thanks to Sheila P. for tickets; will find out when we will have the tickets for the winner; with only 1 week to organize, learned much about the process & fairly straightforward so we can duplicate it; event/Rotary went smoothly; ideas to help for next time include: more time to prepare, longer sell time, Rotary offered to sell tickets online. Members agreed to store leftover materials in the Montessori cupboard.
